A multitude of cost-share programs are available to landowners interested in implementing practices that will improve their community's water quality. This brochure gives a brief summary of information about various programs to help individuals and municipalities determine a program that best suits their needs.

Clean Water Neighbor Grants- Any project which increases awareness of 1) water quality caused by nonpoint pollutant sources and 2) effective nonpoint source pollution control measures. Project sponsors must organize and host a "Clean Water Neighbor Workshop" sometime during the course of the Project. Project sponsors must invite Kansas Department of Health and Environment personnel to participate in the workshop. A wide variety of project activities have been supported, including: high school student water quality monitoring teams, stream cleanup, sedimentation pond to protect public water supply lake, composting workshops, etc. For more information, visit the Kansas Department of Health and Environment online at www.kdhe.state.ks.us or the Hillsdale Water Quality Project online at www.hwqp.org.

Conservation Easement Program- Landowners can voluntarily enroll in riparian and wetland areas into conservation easements. Public and private projects are eligible for this open enrollment program. The easement agreements cover best management practices recommended under the Wildlife habitat Improvement Program. Protection and restoration of riparian and wetland areas are important considerations of this program. Easements can be short-term agreements or in perpetuity. Conservation Reserve Program (CRP) Designated- Landowners willing to take land that has been planted or could be planted out of crop rotation for 10 to 15 years are eligible to receive annual rental payments in exchange. Marginal pastureland is eligible for the program. Additional stipulation require that the sire be one of the following: highly erodible, be considered a cropped wetland, be subject to scour erosion, be located in a conservation priority area or be cropland associated with non-cropped wetlands. A 50 percent maximum cost-share is allowed. Registration for this program takes place each spring as announced. Conservation Reserve Program (CRP) Continuous- Eligible acreage devoted to certain special conservation practices, such as riparian buffers, filter strips, grassed waterways, shelter belts, living snow fences, salt tolerant vegetation and shallow water areas for wildlife, may be enrolled at any time under the continuous registration program. Environmental Education Grants Program- This grant, offered by the Environmental Protection Agency, is designed to support programs that create, demonstrate or disseminate information concerning environmental education practices, methods or techniques. A 25 percent match is required. Eligible applicants include local schools and nonprofit organizations. For more information, visit the Environmental Protection Agency online at www.epa.gov.

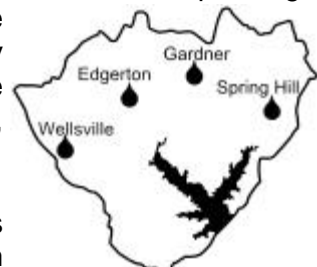
Environmental Quality Incentive Program (EQIP)- Technical, educational and financial assistance is provided by this program as a way to encourage agricultural landowners to adopt new best management practices targeted to reduce soil erosion, reduce phosphorus loading, sustain grasslands or improve riparian areas. Practices can include animal water management facilities, terrace, filter strips, tree planting and permanent wildlife habitat. The program requires landowners to sign a five to 20 year contract tied to incentive payments. Cost-share payments of up to 75 percent for practices are also available. Total cost-share and incentive payments are limited to \$10,000 per person per year and 50,000 for the length of the contract. Registration will be done in the springtime. Forest Stewardship Program- The Forest Stewardship Program provides technical assistance to landowners to encourage proper management of their forest and to ensure water quality, reduce erosion and enhance many other benefits that riparian forests can provide. District foresters develop plans with assistance from appropriate federal and state agencies under the Stewardship Incentive Program. Landowners must include all their forestlands in the plan. Hillsdale Water Quality Project- Landowners within Hillsdale Lake's Watershed can apply for cost-share assistance on practices that will reduce erosion and amount of other pollutants entering the lake's tributaries. Only practices that are not eligible for funding through other eligible programs are considered. An example of potential applicants would be landowners with property that is not used for agriculture, since agriculture programs are available through the Paola Natural Resources Conservation Service online at www.nrcs.usda.gov. Registration is continuous. Visit the Hillsdale Water Quality Project online at www.hwqp.org.

Kansas Conservation Tree Planting Program- Low-cost tree and shrub seedlings are offered for use in establishing riparian filter strips, woodlots, erosion control planting, wildlife habitat plantings, windbreaks and other conservation tree plantings. Orders may be placed at any time and are typically delivered between mid-March and May. District foresters are available to prepare management plans. Missouri Stream Team- The Missouri Stream Team promotes citizen awareness and involvement in river and stream

conservation through education, stewardship and advocacy. Missouri Stream Teams have been active form amore that 11 years. There are more than 2,000 stream teams, or more than 37,260 volunteers working to complete more that 26 activities leading to Missouri Waterways. The program is not limited to volunteers living in Missouri. Kansans are also offered the opportunity to work with the program. National Tree Trust- Through its partnerships, with hundreds of community groups and thousands of volunteers, the National Tree Trust plants millions of trees on public land and along the nation's roadsides. The National Tree Trust promotes environmental stewardship and a greater awareness of the value of trees and students. The program offers the tools necessary to aid students in growing seedlings. The program's mission is to serve as a resource for volunteers interested in planting, growing and maintaining trees in urban and rural communities and along the nation's highways. Nonpoint Source Pollution Control Fund- Funds provided by the State Conservation Commission can aid landowners interest in the protection and restoration of surface water and groundwater quality. Registration for this program, which supports water well plugging, septic system upgrades, private dumpsite cleanups, pasture and hayland management begins July 1. The program is open until all of the funds have been allocated. For more information, visit the Miami County Conservation District online at www.nacdnet.org.

Private Lands/Partners for Fish Wildlife Program- The Private Lands/Partners for Fish Wildlife Program is designed to provide landowners with opportunities to restore, enhance or create wetlands at minimal expense. The program focuses on migratory birds and habitat restoration. Depending on the site, contracts can be established for a time frame ranging from 10 to 30 years. The landowner retains all rights. Technical advice and partial payment for construction is provided. The maximum allocation per project is \$10,000. Visit the United State Fish and Wildlife Service online at www.fws.gov.

Riparian and Wetland Protection Program- These State Conservation Commission funds can aid landowners interested in the conservation and management of riparian areas and wetlands. Financial Assistance is provided to implement practices such as critical area plantings, fencing, field borders, filter strips, livestock exclusion, proper grazing wetland restoration, tree revetments and cut-willow plantings. Registration for this program is continuous. For more information, visit the Miami County Conservation District online at www.nacdnet.org.

River Friendly Farms Environmental Assessment Tool- This program provides property owners a \$250 incentive for completing a farm assessment manual and developing an action plan. The confidential and voluntary self-assessment tasks between six and eight hours to complete. Once the workbook is finished, the program provides some cost-share assistance for competing improvements notes as priorities by the landowner. Presently, funding is available until June, 2004. 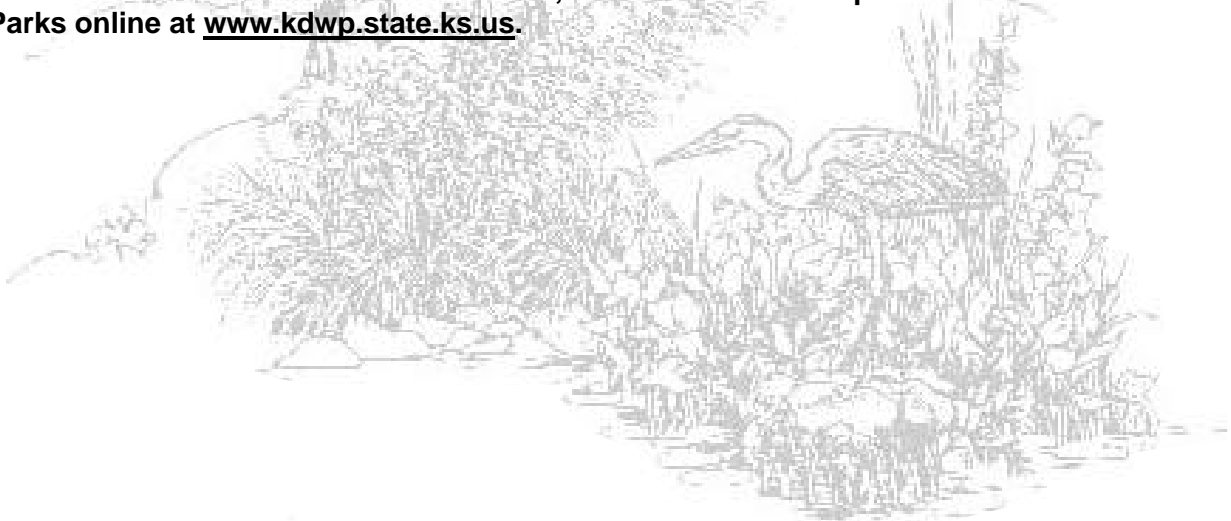

Stream Stewardship- Any project focused on improving riparian area condition. Projects have included bank stabilization demonstrations, alternative livestock watering sites, abandoned dump cleanups, etc. Project sponsor must agree to be a resource contact person for others interested in knowing more about the measures and practices installed under the project. Water Resources Cost-Share Program- Cost-share assistance is provided to landowners interested establishing soil conservation practices. They can include grass seedlings, terraces, waterways, agricultural waste control facilities and critical area plantings. A maximum of 70 percent cost-share is provided with a dollar amount of \$5,000. For more information, visit the Miami County Conservation District online at www.nacdnet.org.

Wetlands Reserve Program (WRP)- This voluntary program encourages the restoration and protection of wetlands on private property. Landowners receive financial incentives to enhance their wetland in exchange for retiring marginal agricultural land. Persons who have owned their land for at least one year can receive up to 100 percent of their restoration costs if a permanent easement for the wetland is granted. Up to 75 percent of the costs can be secured for lesser commitments. Eligible sites include wetlands farmed under natural conditions, farmed wetlands, prior converted cropland, farmland that has become a wetland as the result of flooding, rangeland, pasture or production forestland where the hydrology has been significantly degraded and can be restored, riparian areas linking protected wetlands, land adjacent to protected wetlands that contribute significantly to wetland functions and previously restored wetlands. Wildlife Habitat Improvement Program (WHIP)- Persons wanting to develop and improve wildlife habitat on private lands can receive technical assistance to help establish and improve fish and wildlife habitat. Property owners must agree to develop a long-term wildlife habitat management plan that outlines the landowner's goals for improving the habitat. It must include a list of practices and installation schedule. Maintenance of the improvements must also be detailed. **Landowners willing to make a minimum of a 10-year commitment can receive up to 75 percent cost-share. Technical Assistance

Business Assistance- The Pollution Prevention Institute, based in Manhattan, Kan., provides confidential assistance, on-site assessments and training seminars for businesses. The institute provides technical and regulatory compliance with the goal of helping businesses eliminate or reduce pollution before it is generated, increase their use of raw materials and resources and maintain information about industry regulations. The institute works in partnership with the Kansas Small Business Environmental Assistance Program. The program features a consortium of advisors who provide on-site assessments, informational sheets, workshops and technical aid. Energy Conservation- Businesses looking for ways to conserve more energy can receive technical assistance from the Environmental Protection Agency's Small Business Energy Star Program. Firms agreeing to participate in the voluntary program are assisted with efforts to survey current equipment, determine potential energy-efficiency upgrade options and the financial payback of making the improvements. Conservation Planning- Individuals, groups or governmental entities may contact the Natural Resources Conservation Office for support creating a conservation plan designed to protect, conserve and enhance a site's natural resource problem-solving and management process integrating natural resource, economic and social considerations. Riparian Areas- Landowners interested in re-establishing a riparian area or creating a riparian area may receive technical assistance from the Kansas State Conservation Commission or the Kansas Forest Service. Streams- Landowners interested in undertaking work within a stream may need a permit from the U.S. Army Corps of Engineers. They can provide limited technical assistance on the proposed project. Contact the U.S. Army Corps of Engineers online at www.usace.army.mil.

Site Assessments- A cooperative effort between Kansas State University and the Miami County Extension office has generated a risk-management guide for homeowners. Home*A*Syst includes a step-by-step guide for identifying and mitigating hazardous environmental conditions. Wetlands- Landowners interested in determining if their agricultural site encompasses a wetland before draining an area may receive technical assistance from the Paola Natural Resources Conservation Service. Projects in an urban setting or on developing property are

reviewed by the U.S. Army Corps of Engineers. They can provide limited technical assistance and a list of approved wetland consultants. Visit the Miami County Conservation District or Paola Natural Resources Conservation Service online at www.nacdnet.org or www.nrcs.usda.org, respectively.
